- A) Strict compliance with all fire sorely provisions as per the condition of Provisional No objection certificate, issued and par 4 national Building Code of India and of Building. particularly the following should ensured at all times.
 - 1. The aggregate with/capacity or exists/stairs shall remain compliant with NBC for safe evacuation of occupants.
 - 2 Fire-resisting doors to limit the spread ad or fire and for preventing smoke and finesses form entering exit stairs, lifts which impedes safe evacuation safe it is an essential pre-requisite for life safely.
 - 3. No temporary Such as lens or with thatched construction should allowed for education institutions.
 - 4. Every room with a capacity or 45 students shall be maintained obstruction free minimum two doorways.
 - B) Fixed firefighting Equipment as per table 23 part-4 or NBC

The following fire safety extinguishers shall be maintained in working condition at times.

C) (i) Fire Extinguishers:

The, following fire extinguishers shall be maintained in trim working condition fit all times. As per 15.3190:1992.

- (a) Two 9 Itrs. Water expelling extinguishers and one 4.5 K2 CO2 extinguisher and one 5 kg. DCP Extinguisher for every 600sq.Mtrs. Radius.
- (b) Four 9 ltrs. Round bottom Fire buckets (Two filled with water and two filled the dry sand) for every 600Sq.Mtrs. built up area/per floor should be hung to a stand*
- D) Evacuation plan showing exit routes and recommended action plan be displayed at conspicuous locations shall be exhibited at all times.
- E) Fire drills shall be conducted once in every 3 months in consultation with the local station Fire Officer.
- I. Adequate ventilation to provide the prevent smoke logging and adequate precautionary shall be taken against fire.
- 2. Exists should not be blocked and staircases also
- 3. All electrical fittings should be concealed and no. open wires (or) Temporary connection shall not be used within the college premises.
- 4. Highly inflammable liquids Shall not be stored in the premises.
- 5. Cooking of rood where essential should be done at n safe place away from the building where students are located for education.
- 6. Perfect good housekeeping is not maintained at the place at the place at all the tints.
- 7. Naked lights/open Fires shall not be allowed in the Premises.
- 8. Whenever any further raise in the height or the building again, this department may be addressed a NO Objection Certificate 10 recommend for fixed fire fighting's Equipment as per scale prescribed in Table 23 part-4 of NBC

The correspondent is requested to pay special attention to S.NO.C and also the compliance of all the above norms to ensure life safety of the inmates at II Limes.
